

## INFORMATION ON THE PROCESSING OF PERSONAL DATA ARTICLE 13 EU REGULATION 2016/679

Audits, checks of processing procedures and verification of compliance with current safety, environmental and personnel regulations</li><li>4. Any other checks deemed appropriate to verify compliance with certain standards set by our customers</li></ol>
Legal basis for processing	The processing of your data is necessary for the execution of the contract, any refusal to provide the requested data will result in the non-conclusion of the contract. The processing of your data may take place in hard copy and computerised form.
Recipients	Your data may be disclosed to: <ul style="list-style-type: none"><li>- authorised in-house entities operating under the direct control of the data controller;</li><li>- public entities that request it on the basis of a legal provision</li><li>- banking and insurance institutions that provide services functional to the purposes indicated above;</li><li>- external managers for the provision of services functional to the pursuit of the purposes indicated.</li></ul> Your data will not be disseminated.
Data transfer abroad	Data may only be transferred within the EU or to countries that guarantee adequate data protection in accordance with the GDPR.
Conservation period	Your personal data, which are processed for the purposes indicated, will be retained for the period of the duration of the contract and, thereafter, for as long as the data controller is subject to retention obligations for tax purposes or for other purposes provided for by law or regulation. Beyond that period they will be destroyed.
Rights	You have the right to request <ul style="list-style-type: none"><li>- the portability of your data</li><li>- access to your data;</li><li>- rectification of inaccurate data</li><li>- the integration of incomplete data;</li><li>- the cancellation of the same when no longer necessary</li><li>- the restriction of processing;</li><li>- to object to the processing at any time in the event of special situations concerning you.</li></ul> You have the right to lodge complaints with the supervisory authority: Data Protection Authority.
